### Regulations and Privacy Policy of the "Recigar 2.0" Mobile Application

- 1. This document outlines the terms of use and data processing for the Recigar 2.0 mobile application (hereinafter referred to as the "Application"), developed by Adamed Pharma S.A. (hereinafter referred to as the "Publisher"), with its registered office at 6A Mariana Adamkiewicza Street, Pieńków, 05-152 Czosnów, Poland, NIP: 7311751025, REGON: 472293752, KRS: 0000116926, email: adamed@adamed.com
- 2. The "Recigar 2.0" Mobile Application is intended for adult users seeking to quit smoking with the aid of the RECIGAR medication. The Application reminds users to take their prescribed doses and offers motivational support in their journey to overcome smoking addiction.
- 3. A user of the Application is defined as any individual who downloads and installs the Application on their mobile device (hereinafter referred to as the "User").
- 4. The Application is available for download free of charge from the following platforms:
  - a. Google Play,
  - b. Apple Store
- 5. Any costs associated with data transmission are borne by the User and are subject to the terms and rates of their respective service provider.
- 6. Before using the Application, the User is advised to read the "Recigar Drug Information" document, which includes details on indications, contraindications, potential side effects, dosage, and proper use. Alternatively, the User should consult a healthcare professional, as improper use of medication may pose risks to health or life.
- 7. By accepting these Terms and Conditions, the User acknowledges that the Application serves solely as an aid in the smoking cessation process. The Publisher emphasizes that the information provided within the Application is for informational purposes only and does not constitute medical advice, consultation, or recommendations. The content of the Application cannot replace consultation with a healthcare provider, including physicians and pharmacists. Users should always consult a healthcare professional before using any medicinal products and review the product leaflet, which outlines contraindications, side effects, and proper dosage.
- 8. To download and use the Application, the User must have a functional mobile device that meets the following technical requirements:
  - a. For Google Play version: system version 6.0 or higher, SDK 23 or higher.
  - b. For Apple Store version: iOS version 12 or higher.
- 9. The User may discontinue use of the Application at any time by uninstalling it according to their device's instructions.
- 10. Use of the Application is voluntary and free of charge.
- 11. A detailed description of the Application's functionality can be found in Appendix 1 of this document.
- 12. The User retains control over whether to download updates for the Application. Automatic updates are subject to the personal settings of the User's device. If the User does not wish to enable automatic updates, they should disable this feature in their device's settings.
- 13. The Application does not collect, store, or share any personal data that would enable the identification of a specific User. No authentication with external services is required to launch the Application. During use of the Application, statistics regarding usage and errors may be automatically collected. This data is anonymous and does not include any personal identifiers.

- 14. Anonymous data on usage statistics and information provided by the User may be processed by the Publisher for marketing and statistical purposes.
- 16. The Application utilizes Google Analytics, an analytical tool managed by Google Inc. (based in the USA). Users can block Google Analytics from tracking their activity by installing a browser add-on that prevents Google Analytics from sharing such information. Detailed instructions can be found at support.google.com.
- 17. Installation of the Application is contingent upon acceptance of this document, which is presented to the User during installation. This document is also available within the Application under the "Settings" tab.
- 18. In the event of changes to this document, a new version of the Application will be made available to the User. Information regarding any updates will be provided in the version history available in the Google Play and Apple Store.
- 19. Matters not addressed in this document shall be governed by the applicable laws of Poland.

### Appendix No. 1 to the Privacy Policy of the "Recigar 2.0" Mobile Application

# **Description of the Application's Functionality**

- 1. First Launch upon the initial launch, the user is prompted to provide data necessary for the proper functioning and personalization of the Application:
  - a. Confirmation of having read the information regarding the Recigar drug, as well as the Terms and Conditions and Privacy Policy of the Recigar Application.
  - b. Responses to initial questions:
    - a. The date since the user stopped smoking,
    - b. The date since the user started taking the Recigar drug,
    - c. The preferred time for taking the first dose of Recigar,
    - d. The user's daily expenditure on cigarettes prior to quitting smoking.
- 2. Alerts the Application features a reminder system for taking the prescribed doses of Recigar on specified days and at set times. The dosing schedule follows the Recigar Summary of Product Characteristics (SmPC). Reminders are sent in the form of notifications on the user's mobile device. Clicking on the notification redirects the user to the Application.

#### 3. Motivation:

a. Users can earn achievements for consecutive non-smoking days, accompanied by motivational messages that recognize their progress.

- b. Achievements will be displayed on the Application's screen when it is launched, provided the user has earned a new achievement.
- c. Statistics feature displays the following:
  - a. Number of days the user has been taking Recigar,
  - b. Number of doses taken,
  - c. Number of days without smoking,
  - d. Total amount of money saved since quitting smoking.
- d. Users can edit their settings within the Application.

# 4. Additional Notifications

The Application also sends additional notifications related to motivation, diet, and physical activity to support the user's journey.

# 5. Goal Setting

The user can specify a savings goal (e.g., what they are saving for) as motivation for quitting smoking.

### 6. Sharing

- information about quitting smoking with Recigar,
- information about the number of days without a cigarette,
- information about the amount saved.
